The legal basis and purpose of processing personal data is to take measures before concluding and issuing an insurance contract, including the fulfillment of Colonnade's legal obligation to assess an insurance risk and assess needs (suitability of the offered product). In the case of concluding a contract via the Internet, the data provided will be automatically processed or profiled, that is, without human intervention. The provision of personal data is necessary for the conclusion and issuance of an insurance contract and for the fulfillment of Colonnade's legal obligations. It is not possible to conclude an insurance contract without providing personal data. The provision of a telephone number and an e-mail address is voluntary, except when it is necessary for the delivery of an insurance file. The general insurance terms and conditions provide complete information about the personal data controller, the purpose of personal data processing, the legitimate purposes of personal data processing, the categories of recipients of personal data, the transfer of data outside the European Economic Area , the duration of personal data processing, the existence of an automatic decision-making process, the right to file a complaint with the supervisory authority, the mandatory or voluntary nature of the provision of certain elements of personal data, the right of access to personal data rights, the possibility of correction, deletion or restriction of processing or the right to oppose processing, as well as the right to transfer data and the right to withdraw consent.
